Asylum and Persecution

What is asylum?

- A legal status granted to allow an individual to obtain refuge in another country due to past persecution or a well-founded fear of future persecution
- On account of: race, religion, nationality, membership in a particular social group, political opinion

What is persecution?

Individualized harm inflicted by the government or by a group that the government is unable or unwilling to control; not harm arising out of civil strife or anarchy; establishing past persecution raises a presumption of future persecution

- Does not need to be physical, can include: "the deliberate imposition of severe economic disadvantage or the deprivation of liberty, food, housing, employment or other essentials of life"
- Must be more than "mere harassment or discrimination"

"torture" means an act committed by a person acting under the color of law specifically intended to inflict severe physical or mental pain or suffering (other than pain or suffering incidental to lawful sanctions) upon another person within his custody or physical control

- "severe mental pain or suffering" means the prolonged mental harm caused by or resulting from
- (A) the intentional infliction or threatened infliction of severe physical pain or suffering;
- (B) the administration or application, or threatened administration or application, of mind-altering substances or other procedures calculated to disrupt profoundly the senses or the personality;
- (C) the threat of imminent death; or
- (D) the threat that another person will imminently be subjected to death, severe physical pain or suffering, or the administration or application of mind-altering substances or other procedures calculated to disrupt profoundly the senses or personality;

Torture....

- is the deliberate intention to destroy the physical and/or psychological well-being of an individual.
 - impacts the will and dignity of an individual.
 - is documented in 151 countries.
 - is a sociopolitical act.
- "a strategy used to undermine political leadership and intimidate entire communities so that they will submit to the will of those in power or those seeking power"


How can clinicians help?

- Primary Purpose of the Clinical Evaluation: to establish
 the facts relating to alleged torture events, and to
 evaluate and document the level of consistency of these
 events and the physical and psychological evidence of
 torture and maltreatment
- Role of Clinicians: forensic evaluations, critical pieces of evidence (often the only evidence) when human rights violations are alleged, corroborates the suffering described, medical-legal affidavits, live testimony, elicit relevant information which client may not have shared with their counsel, refer for treatment
 - ~ 90% of PHR's confirmed case outcomes are positive compared to national average of ~ 30-40%

What is the role of a medical evaluator?

- Advocacy through objectivity
- Not a treatment relationship
- Carrying out the recommendations established by the internationally accepted "Manual on the Effective Investigation and Documentation of Torture and other Cruel, Inhuman or Degrading Treatment or Punishment" a.k.a., "Istanbul Protocol" (1999)
- Conducting the assessments in our role as expert witnesses, providing evidence for the asylum interview or hearing
 - Different types of cases require different types of experts! (Psych, OB/Gyn, Physical exam)




